I waive any and all claims I may have against Train Mountain which are due to the inherent risks associated with Train Mountain, its premises and/or its program.

- conduct myself in a proper manner;
- display courtesy and consideration in dealing with Train Mountain personnel and other persons on the premises;
- comply with all federal, state and local laws and regulations;
- no illegal drugs to be used or possessed on Train Mountain property at any time;
- observe and comply with all rules and regulations that Train Mountain may prescribe by either oral or written notice (posting on the premises) of safety and convenience to all persons on the premises.
- photography is permitted on the premises

I acknowledge and understand that no guarantees, express or implied, are made by Train Mountain, its agents or employees as to the condition of its property, or of any improvements made.

I understand that I am a guest and if I am observed in violation of any law or regulation I can be asked to leave the property (with no refund of payment).

In consideration for the privilege of entering the premises of Train Mountain and to participate in its activities thereon, I agree to release, hold harmless and unconditionally indemnify and defend Train Mountain and its agents and employees against any and all liability, costs, expenses, claims and damages which Train Mountain, its agents or employees may at anytime suffer or sustain or become liable for by reason of any accidents or incidents, damages or other injuries, either to the person or property or both in any matter arising from the agreement or from operations or activities performed here under including but not limited to any negligent act or omission of Train Mountain and its agents or employees.
